Thanks to all our sponsors, speakers, exhibitors and attendees who helped make 2016 a success!



SERDC announces updated demand map

In a new 2016 study, SERDC determined that over 350 key Southeastern manufacturers look to recycled feedstock to develop new consumer goods. When communities invest in local recycling collection programs, they're supporting regional manufacturers who depend on recycled plastic, glass, metal, and paper to make new consumer goods.

News from... Arkansas Department of Environmental Quality

Recycling Related Projects at ADEQ

Arkansas Department of Environmental Quality (ADEQ) recycling personnel have been busy in the last quarter of the year implementing projects announced at the 2016 Arkansas Recycling Coalition conference, completing the annual State of Recycling report, and looking ahead to 2017.

The ADEQ booth at the ARC conference focused on two major ways for recycling facilities/programs to electronically get the word out about what they are doing. The first, Earth 911, is a national resource that helps people locate your facility when they are looking for a place to recycle. The second, an electronic Scrapbook of Arkansas Recycling, gives a more personal account of your facility/program.

The Earth911 recycling directory allows users to type in materials they want to recycle and zip codes to find nearby collection locations. More than 350 materials are listed, including many electronic items and household hazardous wastes. The directory is available via a website (Earth911.com), a toll-free telephone number (1-800-CLEANUP), and a free mobile app (iRecycle). However, the directory is only as good as the data provided. Earth911 and ADEQ already are partners. ADEQ lists Earth911 and the iRecycle app as resources. Please help ADEQ make sure this searchable directory is complete and up to date. Contact your local solid waste management district or Betsy Spetich at ADEQ to find out how to include information about your facility/program.

The electronic Scrapbook of Arkansas Recycling showcases accomplishments, challenges, and plans of entities collecting recyclable materials in Arkansas. The idea for this scrapbook came from a hard copy publication created in 1999 to commemorate Arkansas's reaching its first legislated recycling goal

(for the year 2000) two years early. Like the original publication, the electronic scrapbook includes photos and information submitted by recycling programs throughout the state. Unlike the original, the electronic scrapbook is dynamic, meant to be updated and added to. Any public or private drop-off collection site or curbside recycling program can be included by completing a form on the ADEQ website. Go to https://www.adeq.state.ar.us/poa/recycling/scrapbook. aspx to view the scrapbook or to enter information about your facility/program.

The State of Recycling in Arkansas report summarizes the quantities of different materials recycled in the past year and offers articles related to recycling in the state. It also provides the annual recycling rate, a calculation of tonnage recycled as a portion of the total waste stream. This year's recycling rate of 46.6 percent is an increase from the 2015 rate of 45.5 percent. In addition, Arkansans landfilled only 401,594 tons more than they recycled, the lowest difference since tracking began. ADEQ provides a variety of programs and services to increase awareness of sustainable waste management practices—including waste reduction, recycling, and composting—in the state. For 2017, the agency looks forward to continuing work with recycling facilities, elected officials, solid waste management districts, and interested organizations and individuals to promote and enhance options for all Arkansans. Great Arkansas Cleanup removes more than 210,000 pounds of litter

LITTLE ROCK (Nov. 21, 2016) – Volunteers participating in the Great Arkansas Cleanup, a three-month event hosted by Keep Arkansas Beautiful (KAB), removed approximately 210,500 pounds of litter during the statewide cleanup effort.

The Great Arkansas Cleanup involved more than 7,300 volunteers at 144 events statewide who contributed a combined 42,958 hours toward litter pickup. These cleanups cleared litter from 541 miles of roadside and 1,194 miles of waterways.

"We appreciate the passion and dedication of our volunteers during the Great Arkansas Cleanup and all year round," said Bob Phelps, executive director of Keep Arkansas Beautiful. "It is because of each and every one of you, that we are able to produce such outstanding results and continue to keep Arkansas clean and green. Volunteers are not paid, not because they are worthless, but because they are priceless."

About the Great Arkansas Cleanup

The Great Arkansas Cleanup grew out of an effort that began 46 years ago as the Greers Ferry Lake and Little Red River Cleanup. In 1985, U.S. Sen. Dale Bumpers guided legislation requiring an annual pickup event during the weekend after Labor Day on all federal lands. This law, the Carl Garner Federal Lands Cleanup Act, honors the founder of the event. Mr. Garner continued his advocacy for a clean and litter-free environment as a member of the Keep Arkansas Beautiful Foundation board of directors until his death in 2014. KAB organized the first statewide GAC in 1989.

About Keep Arkansas Beautiful

As a certified state affiliate of Keep America Beautiful Inc., the Keep Arkansas Beautiful Commission (KAB) works to inspire and educate individuals to reduce litter, recycle and keep Arkansas beautiful. A division of the Arkansas Department of Parks and Tourism, its programs are managed by a three-person professional staff and a ninemember advisory board appointed by the governor. KAB is funded by 1 percent of the eighth-cent Conservation Tax and, by mobilizing volunteers, returns to the state a cost benefit of more than \$6 in community service for each program dollar spent. Regional Recycling and Waste Reduction District's Grants Program
